This was accomplished with a small core paid staff and the services of over 750 volunteers who gave their time and talents to those in need.

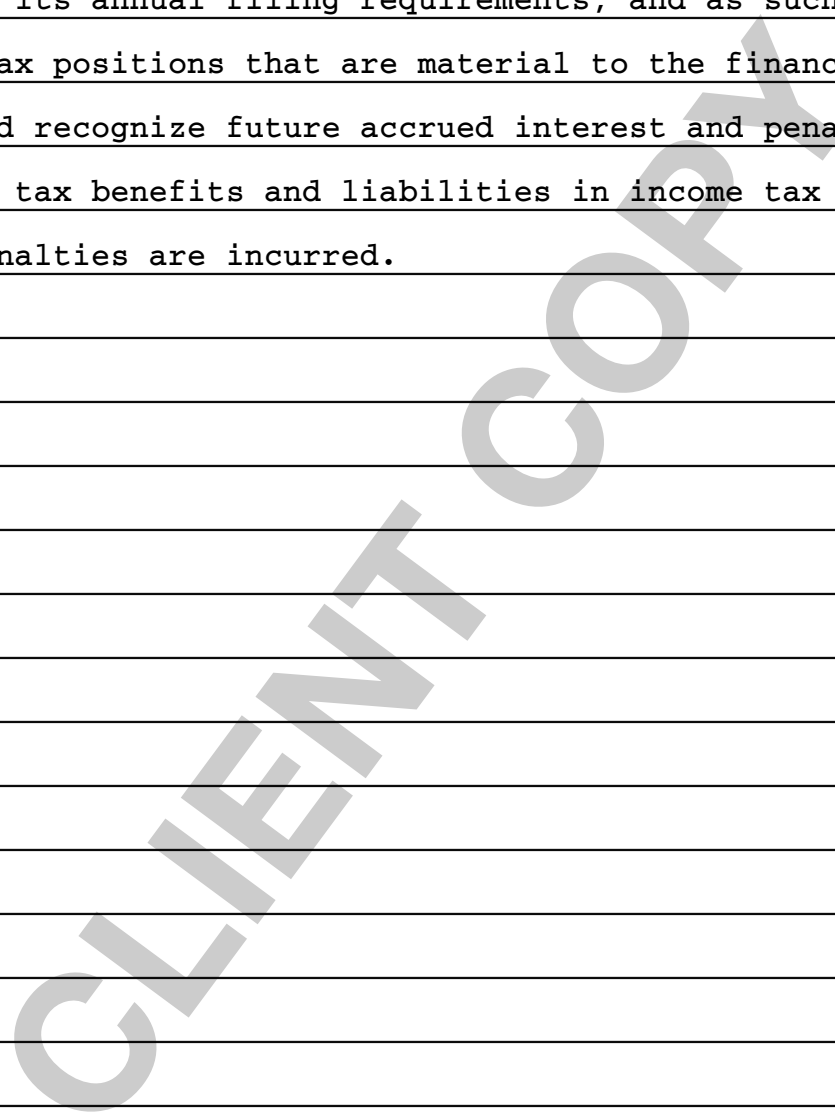
