Patients are all living below 150% of federal poverty guidelines and are not eligible for Medicare, Medicaid, CHIP and other programs. In 2018, the clinic provided nearly 16,000 medical appointments for 6,000 individuals in need in our community. This was accomplished with a small core paid staff and the services of over 600 volunteers who gave their time and talents to those in need.
