Patients are all living below 200% of the federal poverty guidelines and are not eligible for Medicare, Medicaid, CHIP and other programs. In 2021, the clinic had 15,802 appointments with 4,767 individuals in need of medical care in our community. This was accomplished with a small core paid staff and the services of over 1,118 active volunteers who provided over 34,000 volunteer hours of service.
