Maliheh Free Clinic provides free, quality medical care to uninsured and low-income individuals and families in the greater Salt Lake City area. Patients are all living below 250% of the federal poverty guidelines and are not eligible for Medicare, Medicaid, CHIP and other programs. In 2024, the clinic had 14,223 appointments with 4,214 individuals in need of medical care in our community. This was accomplished with a small core paid staff and the services of 523 active volunteers who provided over 27,000 volunteer hours of service.
